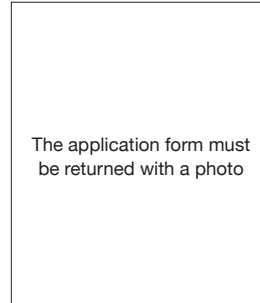

If applying from overseas, you can submit a bank draft in UK Pounds Sterling or a cheque drawn on a UK bank.
